

APPLICATION FOR PERMIT - NORTH ADAMS TRANSFER STATION FY2012

1. PERMIT MUST BE AFFIXED SO THAT IT IS VISIBLE TO THE TRANSFER STATION SCALE OPERATOR. IT MAY BE PLACED IN THE UPPER RIGHT CORNER OF THE FRONT PASSENGER WINDOW. (APPEARS TO BE UPPER LEFT WHEN VIEWED FROM OUTSIDE THE VEHICLE)
2. RESIDENTIAL PERMITS ARE FOR RESIDENTIAL USE ONLY. USE OF A RESIDENTIAL PERMIT FOR COMMERCIAL PURPOSES SHALL RESULT IN THE PERMIT BEING VOIDED.
3. ALL VEHICLES WITH A COMMERCIAL REGISTRATION MUST PURCHASE A COMMERCIAL PERMIT.
4. PERMITS ARE NON-TRANSFERABLE AND ARE VALID ONLY FOR THE VEHICLE FOR WHICH THEY HAVE BEEN PURCHASED. IF A VEHICLE IS DISPOSED OF DURING THE YEAR, BRING THE PLATE RETURN RECEIPT TO THE HEALTH DEPARTMENT OR THE TRANSFER STATION TO OBTAIN ANOTHER PERMIT.
5. VEHICLE REGISTRATIONS MUST BE PRESENTED TO PURCHASE A PERMIT. THE ADDITIONAL PERMIT FEE OF \$5.00 IS VALID ONLY WHEN THE ADDITIONAL PERMIT IS PURCHASED *AT THE SAME TIME* AS THE PRIMARY STICKER.
6. PERMITS WILL BE AVAILABLE BEGINNING TUESDAY MAY 31, 2011 AT THE TRANSFER STATION FROM 9:00 A.M. TO 3:00 P.M. TUESDAY THROUGH FRIDAY AND SATURDAY 8:00 AM. TO 2:00. TEMPORARY PERMITS ARE NOT AVAILABLE FOR COMMERCIAL USE.
